GIVING AND GRANTING unto my said attorney-in-fact full power and authority to do and perform all and every act, deed, matter, and thing whatsoever in and about my estate, property, and affairs as fully effectually to all intents and purposes as I might or could do in my own proper person if personally present and hereby ratifying all that my said attorney-in-fact shall lawfully do or cause to be done by virtue of these presents.

I HEREBY RATIFY all that my attorney-in-fact may do in the premises by virtue of this Power of Attorney, which shall remain in full force and effect until written notice of its revocation, signed by me, shall have been received by my attorney-in-fact.
