D. Shedd, his heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina and being shown as Lot No. 100 on a Plat of Western Hills recorded in the RMC Office for Greenville County in Plat Book QQ, Pages 98-9 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Tucson Drive at the joint front corner of Lots 99 & 100 and running thence with the common line of said lots S. 16-43 E. 174.1 feet to an iron pin; thence S. 73-30 W. 100 feet to an iron pin; thence N. 16-43 W. 173.8 feet to an iron pin on the southerly side of Tucson Drive; thence with said Drive N. 73-17 E. 100 feet to the point of beginning.
