the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

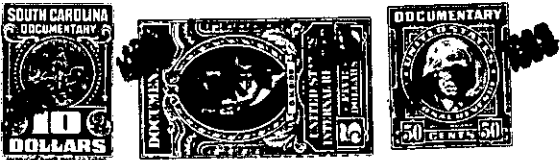
J. O. Shaver, his heirs and assigns forever:

Beginning at an iron pin on the southeasterly side of Ridgecrest Drive at a point 75 feet southwest of the southerly corner of the intersection of Ridgecrest Drive and Wellington Avenue, joint front corner of Lots 4 and 5, and running thence along the joint line of said lots, S 38-19 E, 197 feet to an iron pin; thence S 58-00 W, 70 feet to an iron pin; thence along the joint line of Lots 3 and 4, N 41-24 W, 177 feet to an iron pin on the southeasterly side of Ridgecrest Drive; thence along the southeasterly side of Ridgecrest Drive, N 43-11 E, 80 feet to the point of beginning.
