ALL our rights, titles, equities and interests in and to those certain water lines and water mains, situate, lying and being in and under the following city streets:

Lady Marion Lane,  
LeGrand Boulevard,  
Nottingham Road, and  
Parkins Mill Road

in the City of Greenville, County of Greenville, State of South Carolina, within the area known as, and serving, SHERWOOD FOREST SUBDIVISION, according to a plat of SHERWOOD FOREST, made by Dalton & Neves, Engineers, August, 1951, recorded in the RMC Office of Greenville County, South Carolina, in Plat Book "GG", at pages 70 and 71.

The water lines and water mains hereby being conveyed on Parkins Mill Road are to include, and be limited to, only those which serve Sherwood Forest as above referred, and does not include any other lines in which the grantors may have any other interest located on Parkins Mill Road
