All that certain piece, parcel or lot of land with any improvements thereon situate, lying, and being on the eastern side of West Castle Road in Pine Hill Village, Gantt Township, Greenville County, South Carolina, shown and designated as Lot 159 on a plat of Pine Hill Village, prepared by R. K.
