KNOW ALL MEN BY THESE PRESENTS, that I, George W. Marsh, of Greenville County,

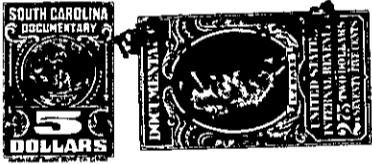
in consideration of Twenty-Five Hundred and No/100-----(\$2500.00)----- Dollars,

M. C. Office for Greenville County in Plat Book L, pages 56-57, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots Nos. 12 and 13, which iron pin is situate 526.6 feet Southwest of the intersection of Cammer Avenue and Meyers Drive and running thence along the Northwestern side of Cammer Avenue, S. 55-36 W. 66.8 feet to an iron pin at the corner of Lots Nos. 13 and 14; thence with the line of Lot No. 14, N. 47-50 W. 177.4 feet to an iron pin in the rear corner of Lot No. 14; thence N. 42-07 E. 65 feet to an iron pin at the rear corner of Lot No. 12; thence with the line of Lot No. 12, S. 47-50 E. 193 feet to the beginning corner; being the same conveyed to me by Ray T.
