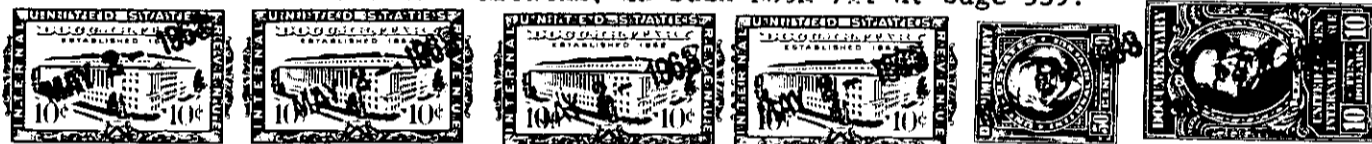

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 17 as shown on a plat of Property of Wm. R. Timmons, Jr., prepared by C. O. Riddle, dated May, 1961, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book XX at page 9, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Lilac Street at the joint front corner of Lots Nos. 16 and 17, and running thence with the Northwestern side of Lilac Street S. 50-37 W. 67.6 feet to an iron pin; thence continuing with the Northwestern side of Lilac Street S. 58-53 W. 52.4 feet to an iron pin at the joint front corner of Lots Nos. 17 and 18; thence with the line of Lot No. 18 N. 31-07 W. 150 feet to an iron pin; thence with the rear line of Lot No. 9 N. 52-08 E. 79.8 feet to an iron pin at the joint rear corner of Lots Nos. 16 and 17; thence with the line of Lot No. 16 S. 46-09 E. 155 feet to the point of beginning.
