All that certain piece, parcel or lot of land situate, lying and being in the Town of Travelers Rest, in Bates Township, County of Greenville, State aforesaid, and being all of Lot No. 6 and a portion of the southern part of Lot No. 7 as shown on plat of property of the grantor made by W. J. Riddle in February, 1940, said plat being recorded in the R.M.C. Office for the County and State aforesaid in Plat Book 00, Page 110, the property hereby conveyed having the following courses and distances, to-wit:

BEGINNING at an iron pin on the eastern side of Willis Street, which runs off of Love Drive, at corner of property of J. G. Willis, Jr., and running thence along Willis Street, N. 27-40 W., 150 feet to an iron pin or stake on the eastern side of Willis Street; thence in a parallel line with J. G. Willis, Jr., line through approximately the center of Lot No. 7 to an iron pin or stake in the rear line of Lot No. 7; thence along the rear line of Lots Nos. 7 and 6, S. 25-41 E., 150 feet to an iron pin or stake at corner of J. G. Willis, Jr., property; thence along line of J. G. Willis, Jr., property, S. 63-43 W., 84 feet to the beginning corner.
