BEGINNING at an iron pin on the southern side of Gardenia Drive, at joint front corner of lot 75 and lot 76, and running thence with the joint line of said lots, S. 32-57 E. 150 feet to an iron pin; thence S. 57-47 W. 85 feet to an iron pin on the eastern side of Edgemont Avenue Extension; thence with said street, N. 32-57 W. 125 feet to an iron pin; thence along the north-east intersection of Edgemont Avenue Extension and Gardenia Drive in a curved line, the chord of which is N. 12-25 E. 35 feet to an iron pin on the southern side of Gardenia Drive; thence with Gardenia Drive N. 57-47 E. 60 feet to the beginning corner.

This conveyance is subject to all easements, rights-of-ways and restrictions which may appear of record.
