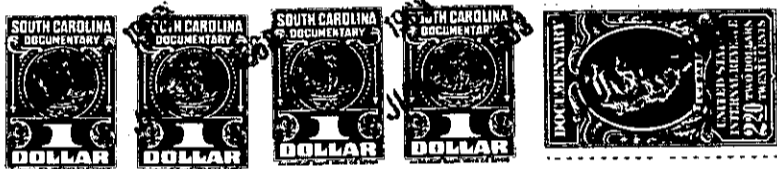
in consideration of **sixteen hundred dollars (\$1,600.00)** Dollars,
