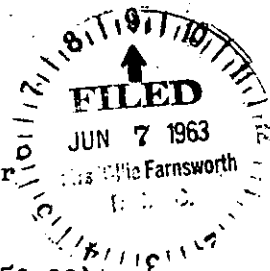

KNOW ALL MEN BY THESE PRESENTS, that I, Annie M. Gudger

in consideration of Seven Hundred Fifty & NO/100 (\$750.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Lester A. Gudger and Nore F. Gudger, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, being known and designated as Lot 83 and one half of Lot 82, of a subdivision known as Bel Aire Estates, as shown on a Plat thereof, dated May 1956, recorded in the R. M. C. Office for Greenville County in Plat Book KK, at Page 19, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Pocshatchie Trail, joint front corners of Lots Nos. 83 and 84 and running thence along the line of said lots, S. 85-30 W. 170 feet to iron pin rear corners of Lots 83, 84, 71 and 72; thence running with rear lines of Lots 72 and 73, N. 4-30 W. 105 feet; thence running N. 85-30 E. 170 feet to iron pin on Pocshatchie Trail; thence running with said Trail 105 feet to iron pin point of beginning.

NO residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet or more frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no business buildings shall be erected on any lot other than lots fronting on Staunton Bridge Road.

THIS conveyance is subject to all easements and rights of way of record.
