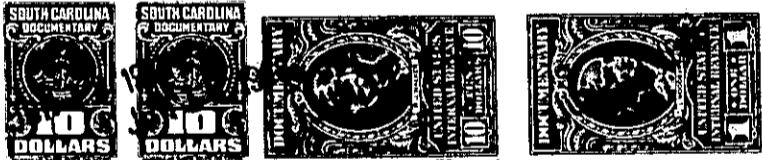

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and
release unto Helen L. Storms, her heirs and assigns:

All that piece, parcel or lot of land situate, lying and being in the State
of South Carolina, County of Greenville, lying on the southern side of Ray
Street, being known and designated as Lot No. 5 of a subdivision known as
Kentland Park as shown on plat thereof prepared by Piedmont Engineering
Service dated March 1962, and recorded in the R. M. C. Office for Greenville
County in Plat Book XX, at Pages 44 and 45, and having the following metes

to an iron pin on the southern side of Ray Street; thence along the southern
side of Ray Street, S. 70-26 E. 70.0 feet to an iron pin, point of beginning.
