ASSIGNMENT OF OPTIONS

WHEREAS, the Greer Chamber of Commerce is the owner of the following described options to purchase real estate in Chick Springs Township, Greenville County, South Carolina:

1. Option from Glenn F. Elmore to the Greer Chamber of Commerce dated May 15th, 1963, concerning 54.22 acres, more or less, on the north side of Southern Railway right of way, on the east side of Suber Road, and on both sides of Princess Creek, about two miles westward from the City of Greer; and for a more complete description, reference is made to said option which was recorded on May 29, 1963, and is registered in Book 724, Page 36, R.M.C. Office for Greenville County.
2. Option from Elise R. Hood, Carl Dewey Hood II and Mattie H. Stroud to the Greer Chamber of Commerce dated May 20, 1963, concerning 14.7 acres, more or less, on the south side of Hood Road and both sides of Princess Creek, about two miles west of the City of Greer, bounded by the lands of John Elmore; and for a more complete description, reference is made to said option which was recorded on May 29, 1963, and is registered in Book 724, Page 38, R.M.C. Office for Greenville County.
3. Option from J. M. Elmore to the Greer Chamber of Commerce dated May 15th, 1963, concerning 50.25 acres, more or less, on the north side of the Southern Railway right of way, extending northward of Hood Road, and bounded on the west by Little Elmore Way; this option also includes any other land owned by the grantor north of the Southern Railway between Little Elmore Way and Suber Road; and for a more complete description, reference is made to said option which was recorded on May 29, 1963, and is registered in Book 724, Page 35, R.M.C. Office for Greenville County.
4. Option from W. L. James to the Greer Chamber of Commerce dated May 23, 1963, concerning 4 acres, more or less, on the north side of the Southern Railway right of way, bounded on the west by J. M. Elmore and on the east by the George Jones Estate, about two miles westward from the City of Greer.
