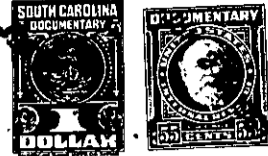
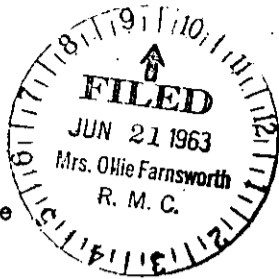

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Charles W. Haynes, his heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 83, as shown on a Plat of Section 2, Bellwood Estates, dated 1955 by Woodward Engineering Company, recorded in the R. M. C. Office for Greenville County in Plat Book GG, at Page 50, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on West Silver Lake Drive, joint front corners of Lots 82 and 83 and running thence along the line of said lots, S. 88-07 E. 186.5 feet to iron pin rear corner of Lots 82-A and 83-A; thence running with rear line of Lot 83-A, S. 3-46 W. 80 feet to iron pin rear corner of Lot 84; thence running with line of said lot, N. 88-07 W. 183.8 feet to iron pin on West Silver Lake Drive; thence running with West Silver Lake Drive, N. 1-53 E. 80 feet to iron pin point of beginning.

NO residence shall be built on any lot costing less than Seven Thousand Five Hundred (\$7,500.00) Dollars; no residence shall be built on said lot nearer than twenty-five (25) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.
