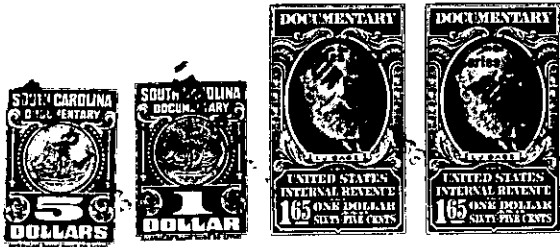

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 69 on plat of Drexel Terrace dated April 1, 1961, and prepared by Piedmont Engineering Service, recorded in the office of the R.M.C. for Greenville County in Plat Book QQ at page 177, and being more particularly described with reference to said plat as follows:

BEGINNING at a point on the westerly side of Dexter Drive, joint front corner of Lots 69 and 70 and running thence along the common boundary of said lots, N. 82-07 W. 167.5 feet to a point in the rear line of Lot 77, joint corner of Lots 69 and 70; thence running along the rear line of Lot 77 and a portion of Lot 78, S. 6-23 W. 100.0 feet to a point in the rear line of Lot 78, joint corner of Lots 68 and 69; thence along the common boundary of Lots 68 and 69, S. 82-07 E. 165.0 feet to a point on the westerly side of Dexter Drive, joint front corner of Lots 68 and 69; thence running along the westerly side of Dexter Drive, N. 7-53 E. 100.0 feet to the point of beginning.

Said lot is subject to protective covenants for Drexel Terrace recorded on April 7, 1961 in the office of the R.M.C. for Greenville County in Deed Book 671 at page 355 and to building set back line as shown on said plat.

This is a portion of the property conveyed to the grantor herein by deed of W. B. Simmons, recorded on April 3, 1961 in the office of the R.M.C. for Greenville County in Deed Book 671 at page 155.
