KNOW ALL MEN BY THESE PRESENTS, that WE, E. W. Singleton and Blanche Singleton,

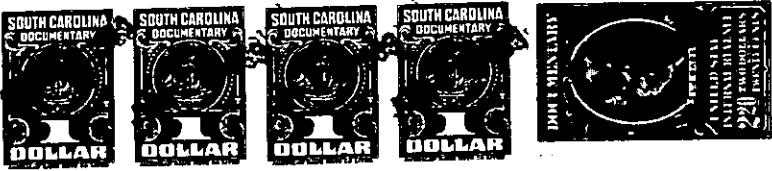
in consideration of Two Thousand and No/100 (\$2,000.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Lloyd W. Gilstrap, his heirs and assigns forever:

All those pieces, parcels or lots of land situate, lying and being in Chick Springs Township, Greenville County, State of South Carolina, on the south side of Highland Avenue and being known and designated as Lots Nos. 48 and 49 on plat of B. F. Flynn Estate recorded in the R. M. C. Office for Greenville County in Plat Book "R", at Page 81 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Highland Avenue at the joint front corner of Lots Nos. 47 and 48 and running thence along the south side of said Avenue in a northeasterly direction 100 feet to the joint front corner of Lots Nos. 49 and 50; thence along the joint line of said lots S. 12-25 E. 220 feet to an iron pin; thence S. 87-25 W. 100 feet to an iron pin; thence along the joint line of Lots Nos. 47 and 48 N. 12-25 W. 193.5 to the point of beginning.

The above is the same property conveyed to the grantor by deed recorded in Deed Book 722, at Page 342.

As part of the consideration for this conveyance the grantee assumes and agrees to pay the balance due on the mortgage to Citizens Building and Loan Association recorded in Mortgage Book 904, at Page 314, the balance now due and owing being \$6500.00.
