Banks, his heirs and assigns, forever:

Frank Williams, recorded in the RMC Office for Greenville County in Plat Book CCC, Page 31 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Haynsworth Road at the joint front corner of Lots 1 & 2 and running thence with the common line of said lots N. 55-36 E. 147.1 feet to an iron pin in the line of Lot No. 3; thence with the line of said lot N. 35-28 W. 92.3 feet to an iron pin; thence S. 56-40 W. 144.2 feet to an iron pin on the northeasterly side of Haynsworth Road; thence with said road S. 33-48 E. 95 feet to the point of beginning.
