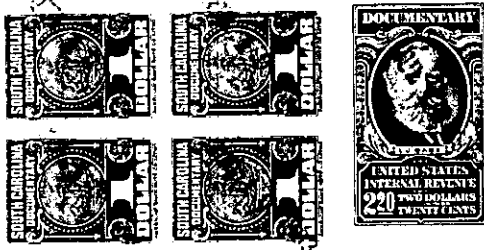
KNOW ALL MEN BY THESE PRESENTS, that I, Charles R. Crane OLLIE FANNING WORTH R.M.C.

ALL that piece, parcel or lot of land near Greenville, South Carolina, Greenville County, being a portion of Lot No. 2 property shown upon plat of J. P. Owens estate, prepared by John C. Smith and J. Coke Smith, dated January, 1952, marked "Plat A", said part being described as follows:
