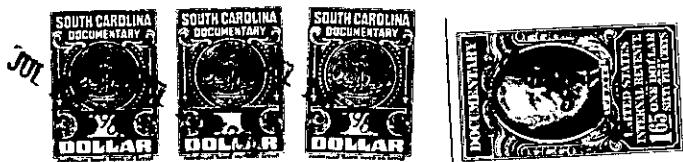
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

BEGINNING at an iron pin on the east side of Central Ave., joint corner with lot No. 42 and running thence along said lot N. 77-10 E. 205 feet to an iron pin in or near center of Stream; thence along center of Stream as line N. 01-17 E. 102.2 feet to an iron pin, corner of lot No. 44; thence along line of said lot S. 77-10 W. 224 feet to an iron pin on Central Ave.; thence along Central Ave. S. 12-50 E. 100 feet to the beginning corner, and being a portion of the same property conveyed to B.
