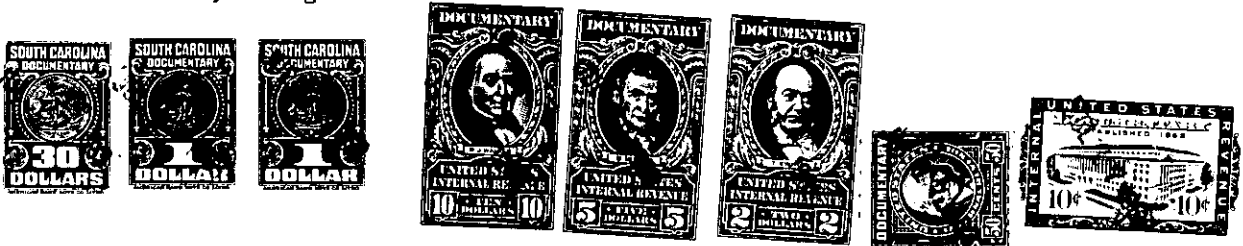
KNOW ALL MEN BY THESE PRESENTS, that I, Roger N. Wesley,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Henry Edward Huggins, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, in the City of Greenville, on the northwestern side of Chick Springs Road and being known and designated as Lot No. 28 and a strip to the rear thereof on plat of Property of Lucy L. Hindman recorded in the R. M. C. Office for Greenville County in Plat Book "W", at Page 177 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Chick Springs Road at the joint front corner of Lots Nos. 27 and 28 and running thence along said Road N. 35-25 E. 85 feet to an iron pin; thence along the line of Lot No. 29 N. 69-33 W. 125.5 feet to the center of a creek; thence along the center of the creek as the line S. 51-25 W. 101.9 feet to a point in the center of said creek; thence along the line of Lot No. 27 S. 72-41 E. 155.9 feet to the point of beginning.
