to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Maybell S. Burrell and her heirs and assigns forever:

All that certain parcel or lot of land situated on the south side of Carey Avenue in the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, designated as all of Lot No. 19 and a part of Lot No. 21 of the W.C. Smith property according to survey and plat thereof by H.S. Brockman, Surveyor, dated May 25, 1936, recorded in Plat Book T, page 10, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the south side of Carey Avenue, corner of Lots Nos. 17 and 19, and running thence along Lot No. 17, S. 27-22 W. 162.7 feet to an iron pin on rear line of Lot No. 18; thence with the rear line of Lot No. 18 and 20, S. 61-02 E. 64.2 feet to an iron pin, corner of Lots Nos. 19, 20 and 21; thence S. 69-37 E. 29.5 feet to an iron pin; thence a new line, N. 24-32 E. 163.8 feet to an iron pin on the south side of Carey Avenue; thence with the south side of Carey Avenue, N. 67-25 W. 28.5 feet to an iron pin, corner of Lots Nos. 19 and 21; thence continuing with the south side of Carey Avenue, N. 63-04 W. 57 feet to the beginning corner.
