the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

WALTER E. POWELL, HIS HEIRS AND ASSIGNS:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 29 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book XX at Page 9, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northeastern side of Penarth Street at the joint front corner of Lots 28 and 29 and running thence with the Northeastern side of Penarth Street S 31-07 E 130 feet to a point; thence following the curvature of the Northeastern intersection of Penarth Street with Fairfax Drive (the chord of which is S 76-07 E 28.3 feet) to a point; thence with the Northwestern side of Fairfax Drive N 58-53 E 114.4 feet to a point; thence continuing with the Northwestern side of Fairfax Drive N 59-52 E 20.6 feet to a point at the joint corner of Lots 26 and 29; thence N 31-07 W 149.6 feet to a point at the joint rear corner of Lots 26, 28 and 29; thence S 58-53 W 155 feet to the point of BEGINNING.
