the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Darlene Elizabeth Shivers, her heirs and assigns forever: An undivided one-half interest in and to the following described real estate:

All that certain piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 18, Section One, of a subdivision known as Brookwood Forest as shown on a plat thereof prepared by C. C. Jones, C. E. dated November 1962 and recorded in the R. M. C. Office for Greenville County in Plat Book XX, at page 97, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Bond Street, joint front corner of Lots Nos. 17 and 18, and running thence along the joint line of said lots, S. 88-55 E. 170.8 feet to an iron pin, joint rear corner of Lots Nos. 8 and 9; thence along the rear line of Lot No. 8, S. 9-30 W. 100.1 feet to an iron pin at the rear corner of Lot No. 19; thence along the line of that lot, N. 88-55 W. 156 feet to an iron pin on the eastern side of Bond Street; thence along the eastern side of Bond Street, N. 0-55 E. 105 feet to the beginning corner; being the same conveyed to me by Mauldin Construction Co. by its deed dated June 11, 1963, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 725, at Page 33.
