Know All Men by These Presents:

in consideration of the sum of One and 00/100 (\$1.00) DOLLARS, and assumption of the mortgage referred to below;

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said NETTIE JANE GAMBRELL, her heirs and assigns, forever, reserving however unto the grantor herein for and during his lifetime the right to use and occupy the premises and to receive the rents and profits therefrom:

ALL that lot of land, with the buildings and improvements thereon, situate on the Southwest side of Cool Brook Drive, near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 52 on plat of Belmont Heights Subdivision, made by C. C. Jones, Engineer, April 1954, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book GG, Pages 54 and 55, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of Cool Brook Drive at joint front corner of Lots 51 and 52, and runs thence along the line of Lot 51, S. 49-39 W., 146.5 feet to a point in the center of a branch; thence with the center of the branch (the traverse line being S. 26-32 E., 55 feet) to a point in center of the branch at joint rear corner of Lots 52 and 53; thence with the line of Lot 53, N. 64-26 E., 168 feet to an iron pin on the Southwest side of Cool Brook Drive; thence along Cool Brook Drive, N. 32-36 W., 50 feet to an iron pin; thence still along Cool Brook Drive, N. 48-41 W., 50 feet to the beginning corner.

Grantee herein assumes and agrees to pay that mortgage given by Jarrell S. Kirkland and Kathleen C. Kirkland to General Mortgage Co., on January 21, 1955, in the original amount of \$9,400.00, recorded in the R. M. C. Office for Greenville County, S. C., in Mortgage Book 624, Page 277.

This is the same property conveyed to the grantor herein by deed of Francis L. Anthony and Barbara Anthony, dated May 24, 1961, recorded in the R. M. C. Office for Greenville County, S. C., in Deed Book 675, Page 77. Grantee to pay 1963 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever, reserving to myself the life estate referred to above. And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
