to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said RICHARD W. McWHORTER, his heirs and assigns, forever:

ALL that lot of land with the building and improvements thereon, situate on the Northwest side of Yorkshire Drive (formerly known as Mable Avenue), near the City of Greenville, in Greenville County, S. C., being shown as Lot No. 64 and the adjoining sixty five (65) feet of Lot No. 65 on plat of property of James M. Edwards, made by Dalton & Neves, Engineers, February 1955, and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book II, Page 121, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of Yorkshire Drive at joint front corner of Lots 63 and 64, and runs thence with the line of Lot 63, N. 47-08 W., 200 feet to an iron pin; thence N. 42-52 E., 165 feet to an iron pin in the rear line of Lot 65; thence through Lot 65, S. 47-08 E., 200 feet to an iron pin on the Northwest side of Yorkshire Drive, in the front line of Lot 65; thence along Yorkshire Drive, S. 42-52 W., 165 feet to the beginning corner.

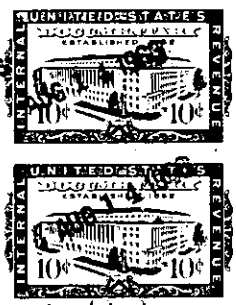
