KNOW ALL MEN BY THESE PRESENTS, that I, William Johnson,

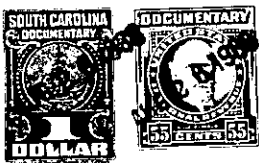
in consideration of Two hundred--(\$200.00) Dollars,
