O. BYERS, his heirs and assigns, forever:

ALL that piece, parcel or lot of land situate on the Northeast side of Riverview Drive, near the City of Greenville, in Greenville County, S. C. shown as Lot No. 78, on Plat of Riverdale, made by Dalton & Neves, Engineers, July 1957, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book KK, Page 107, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeast side of Riverview Drive at joint front corner of Lots 77 and 78, and runs thence along the line of Lot 77, N. 25-40 E., 193.2 feet to an iron pin; thence with the line of Lot 79, S. 82-03 W., 217.3 feet to an iron pin on the East side of Riverview Drive; thence with the curve of Riverview Drive, (the chord being S. 28-30 E., 83.8 feet), to an iron pin; thence still with the curve of Riverview Drive, (the chord being S. 52-30 E., 115 feet), to the beginning corner.
