

Deed for South Carolina

KNOW ALL MEN BY THESE PRESENTS, PHILIP N. BROWNSTEIN, of Washington, D.C.,

as Federal Housing Commissioner, Grantor, for and in consideration of the sum of ONE DOLLAR (\$1.00) and other valuable considerations, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto JERRY V. PLUMMER & DOROTHY L. PLUMMER

Grantee(s), and to the heirs and assigns of said Grantee(s),

All that lot of land in the City of Greenville, County of Greenville, State of South Carolina, designated as Lot No. 7, Block L, on plat of Fair Heights, recorded in Plat Book F at Page 257 of the R.M.C. Office for Greenville County, S. C., and having according to said plat and a recent survey made by R.W. Dalton, the following metes and bounds, to-wit: Beginning at an iron pin on the northwestern side of Cumberland Avenue, the front joint corner of Lots Nos. 6 and 7; thence with the joint line of said lots N. 58-40 W. 140 feet to an iron pin corner of Lot No. 16; thence with the line of said lot S. 31-20 W. 50 feet to an iron pin corner of Lot No. 8; thence with the line of said lot S. 58-40 E. 140 feet to an iron pin on the northwest side of Cumberland Avenue; thence with the northwest side of Cumberland Avenue N. 31-20 E. 50 feet to the beginning corner.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise appertaining or incident.

TO HAVE AND TO HOLD all and singular the premises before mentioned, unto the said Grantee(s), and to the heirs and assigns of said Grantee(s) forever.

SUBJECT to all covenants, restrictions, reservations, easements, conditions and rights appearing of record; and SUBJECT to any state of facts an accurate survey would show.

AND THE SAID GRANTOR covenants that he has not made, done, committed, executed or suffered any act or acts, thing or things whatsoever, whereby or by means whereof, the above mentioned and described premises, or any part or parcel thereof, now are, or at any time hereafter shall or may be impeached, charged or encumbered in any manner or way whatsoever.
