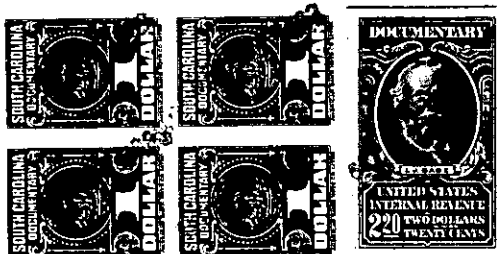
KNOW ALL MEN BY THESE PRESENTS, that Piedmont Land Co.

One Dollar and Other Considerations ----- Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto Carter Lee Bishop and Anne D. Bishop, their heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot #76, of a subdivision known as Homestead Acres, Section 2, as shown on a plat prepared by Piedmont Engineering Service, dated April 26, 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book XX, at Page 143, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Havenhurst Drive, the joint front corner of lots #75 and #76, and running thence S. 7-57 E. 174.6 feet to an iron pin; thence S. 82-26 W. 90.0 feet to an iron pin at the joint rear corner of lots #76 and #77; running thence N. 7-59 W. 174.8 feet to an iron pin on the southern side of Havenhurst Drive; thence along the southern side of Havenhurst Drive, N. 82-32 E. 90.0 feet to an iron pin, point of beginning.
