the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Mary P. B. Singleton, her heirs and assigns, forever:

All that lot of land, with the buildings and improvements thereon, situate, lying and being on the east side of Sycamore Drive, in the City of Greenville, in Greenville County, State of South Carolina, being shown as all of Lot 164 on plat entitled East Lynne Addition, prepared by Dalton & Neves, Engineers, in May 1933, which plat is recorded in the R.M.C. Office for Greenville County, S.C., in Plat Book H, at Page 220, and having, according to said plat, the following metes and bounds, to-wit:
