in consideration of Five Dollars and no/100----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto J. W. Pitts, his heirs and assigns forever:

All those certain pieces, parcels or lots of land in the County of Greenville, State of South Carolina, in Gantt Township, being known and designated as Lots Nos. 56 and 57 of a subdivision known as Oakvale Terrace, according to a survey and plat of the same made by Pickell and Pickell, Engineers, dated March 7, 1946, recorded in the R.M.C. Office for Greenville County in Plat Book M at page 151, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of an unnamed street at the joint front corner of Lots 55 and 56 and running thence along the joint line of said lots, N. 18-30 E. 190 feet, more or less, to an iron pin on the line of other property now or formerly of L. F. Simpson, Jr.; thence along line of that property, S. 72-45 E. 330 feet to an iron pin; thence S. 1-0 W. 153.6 feet to an iron pin on the northern side of said unnamed street; thence along the northern side of said unnamed street, N. 78-50 W. 370 feet to the beginning corner; being the same conveyed to me by Mozelle Frances Moore by deed dated July 24, 1957 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 581 at Page 67.

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
