ALL that piece, parcel or lot of land, lying and being situate on the East side of Old Buncombe Road, near the City of Greenville, in Greenville County State of South Carolina, known and designated as lot #8 on plat of "Casa Loma Estates" made by Piedmont Engineering Service, October, 1947, and recorded in the R.M.C. Office for Greenville County, in Plat Book "S" at page 65, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of Courtney Circle at the joint front corner of lots 7 and 8 and running thence along said Courtney Circle S. 67-05 E. 80.0 feet to an iron pin at the joint front corner of lots 8 and 9; thence running with the line of lot 9, S. 22-55 W. 180.0 feet to an iron pin at the joint rear corner of lots 8 and 9; thence N. 67-05 W. 80.0 feet to an iron pin at the joint rear corner of lots 7 and 8; thence N. 22-55 E. 180.0 feet to the beginning corner.
