ALL OUR RIGHT, TITLE AND INTEREST IN AND TO:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the Western side of Green Avenue, near the City of Greenville, (formerly known as Melrose Avenue), being shown as Lot No. 15 of Block A on Plat of property of Melrose Land Company, recorded in Plat Book A at Page 157, and described as follows:

BEGINNING at a stake on the Western side of Green Avenue, the corner of Lot No. 14, and running thence with the line of said lot in a Northwesterly direction 180 feet to a stake on the C & G Right-of-Way; thence with said Right-of-Way in a Southwesterly direction 50 feet, more or less, to a stake corner of Lot No. 16; thence with the line of said lot in a Southeasterly direction 188 feet to a stake on Green Avenue; thence with the Western side of Green Avenue in a Northeasterly direction 50 feet to beginning corner.
