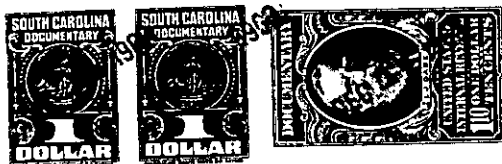
KNOW ALL MEN BY THESE PRESENTS, that **Buster Lewis**

All that piece, parcel or lot of land situate on the South Side of Pack Alley in the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot No. 14 on Plat of Queen Heights, made by N. O. McDowell, Jr. and J. P. Moore, November, 1944, recorded in the RMC Office for Greenville County, S. C. in Plat Book O, page 87, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South Side of Pack Alley at joint front corner of Lots 13 and 14, and running thence along the line of Lot 13, S. 21-45 W. 112.5 feet to an iron pin thence N. 68-43 W. 40 feet to an iron pin; thence with the line of Lot 15, N. 21-45 E. 112 feet to an iron pin on the South side of Pack Alley, thence along the South side of Pack Alley, S. 69-48 E. 40 feet to the beginning corner.
