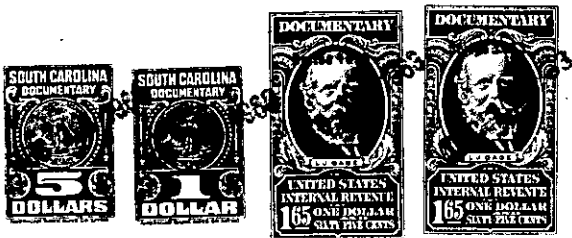

Ernest J. O'Banion Jr. and Frances C. O'Banion, their heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 12 of Shannon Forest, plat of which is recorded in the RMC Office for Greenville County in Plat Book KK, Pages 200-201 and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Shannon Lake Circle at joint front corner of Lots Nos. 12 & 13 and running thence with the line of said lots N. 42-25 W. 228 feet to the high water line of Shannon Lake; thence with said high water line N, 51-36 E. 100.2 feet; thence S. 42-25 E. 221 feet to an iron pin on Shannon Lake Circle; thence with Shannon Lake Circle S. 47-35 W. 100 feet to the point of beginning.

This conveyance is subject to the recorded restrictions applicable to Shannon Forest and to the set-back line and easements as shown on said plat.
