the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto A. B. Batson, J. M. Jackson, B. J. Greene, John Cornell, Ozey Hicks and James Barnett, as Trustees for Travelers Rest Methodist Church, Travelers Rest, South Carolina, their successors and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, adjoining the right-of-way of the Greenville & Northern Railroad, at Travelers Rest, South Carolina, being shown as Lot No. 2 according to a plat prepared by Terry T. Dill, R.L.S. dated October 27, 1961 and recorded in the R. M. C. Office for Greenville County in Plat Book EEE, at Page 99 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western edge of the right-of-way of the Greenville & Northern Railroad at the corner of property now owned by the grantee and running thence with the grantee's property line, S. 89-00 W. 578 feet to an iron pin; thence N. 63-30 E. 510 feet to an iron pin at the right-of-way of the Greenville & Northern Railroad; thence with said right-of-way, S. 28-35 E. 246 feet to the beginning corner; said lot being triangular in shape and containing 1.45 acres.
