to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C. J. MOODY, his heirs and assigns forever,

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, being known and designated as a portion of Lot No. 13 and a portion of Lot No. 12 as shown on recent survey made by C. C. Jones, April 10, 1963 of the property of C. J. Moody and Emmie Lou Swedenburg, recorded in the RMC Office for Greenville County in Plat Book DDD, at page 63 and also shown on the original plat of East Summit View, recorded in Plat Book A, at page 389 and Plat Book F, at page 15 and having the following metes and bounds:

BEGINNING at an iron pin on Bramlett Road, joint front corner of Lots 11 and 12 and running thence South 1-08 East 139.3 feet to an iron pin; running thence North 78-18 East 41.5 feet; running thence North 72-32 East 46.5 feet; running thence South 89-46 East 12.5 feet to corner of property heretofore conveyed by C. J. Moody to Emmie Lou Swedenburg; running thence along Swedenburg line, North 16-27 West 142.4 feet to an iron pin on Bramlett Road; thence along Bramlett Road, South 71-48 West 63.5 feet to the point of beginning.

This deed is made to correct a deed from Emmie Lou Swedenburg to C. J. Moody as recorded in Deed Book 724, at page 332.
