BILLY CLYDE HENSLEY AND LINDA N. HENSLEY:

All that piece, parcel or lot of land situate, lying and being on the North-western side of Collinwood Lane near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 12 as shown on a plat of Collinwood Park, prepared by J.C. Hill, Engineer, dated October, 1962, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book CCC at page 27, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Collinwood Lane at the joint front corner of Lots Nos. 11 and 12, and running thence with the line of Lot No. 11 N. 13-0 E. 160.6 feet to an iron pin in or near a branch; thence with the branch as the line, having a traverse line as follows: N. 81-0 W. 95 feet, more or less, to an iron pin, thence N. 54-22 W. 62.5 feet to an iron pin at or near said branch; thence S. 25-40 W. 127 feet to an iron pin at the joint rear corner of Lots Nos. 12 and 13; thence with the line of Lot No. 13 S. 52-0 E. 168.8 feet to an iron pin on the Northwestern side of Collinwood Lane; thence with the curve of the Northern terminus of Collinwood Lane, the chord of which is N. 62-15 E., 50 feet to the point of beginning.
