the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto

JAMES LINDSEY, his heirs and assigns, forever:

ALL that lot of land lying at the Southwestern intersection of Sharon Drive with Melody Drive, in Greenville County, South Carolina, being shown and designated as Lot No. 69 on plat of an Extension of Sharon Park, made by C. C. Jones, Civil Engineer, dated December 1962, and recorded in the RMC Office for Greenville County, S. C. in Plat Book CCC, page 71, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Western side of Melody Drive, at the joint front corner of Lots Nos. 68 and 69, and running thence N. 85-30 W. 110 feet to an iron pin; thence along the line of Lot No. 70, N. 25-30 W. 105.5 feet to an iron pin on the Southern side of Sharon Drive; thence along the Southern side of Sharon Drive, N. 63-00 E. 127.6 feet to an iron pin; thence with the curve of the intersection of Sharon Drive with Melody Drive, the chord of which is S. 72-00 E., 28.3 feet to an iron pin; thence along the Western side of Melody Drive, S. 27-00 E. 20.7 feet to an iron pin; thence continuing along said side of Melody Drive, S. 11-16 E. 57.7 feet to an iron pin; thence continuing along said side of Melody Drive, S. 4-30 W. 78.1 feet to an iron pin, the beginning corner.

The above described property is hereby conveyed subject to utility rights of way and easements of public record and shown on the recorded plat aforesaid, and to restrictive covenants applicable to Sharon Park Extension recorded in the RMC Office for said County and State in Deed Book 706, page 209.

As a part of the consideration for this deed the grantee herein does hereby assume and agree to pay in full the balance due on that certain mortgage covering the above property in favor of First Federal Savings & Loan Association of Greenville, S. C., which appears of public record.
