

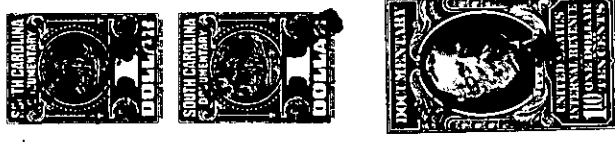

in consideration of Eight Hundred Ten & no/100 - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Jerry Alvin Armstrong his Heirs and Assigns forever:

All that piece, parcel or lot of land lying, being and situate in the County and State aforesaid, Fairview Township, just outside the corporate limits of the Town of Fountain Inn, being known and designated as Lot No. 16 on a plat of Sunset Heights made by W. N. Willis, Engineers, dated Oct. 31, 1958, said Plat of record in the Office of the R. M. C. for Greenville County, S. C., in Plat Book 00 at pages 314, 315, 316 & 317, and being more fully described, according to said plat, to-wit:
Beginning at an iron pin in the Southern edge of State Highway No. S 23-214, joint front corner with Lot No. 17, and running thence along the Southern edge of said Highway N. 65-00 E. 90 feet to an iron pin, joint front corner with Lot No. 15; thence with the joint line of said Lot 15 S. 21-15 W. 195 feet to an iron pin on line of Lot No. 29; thence with the joint line of said Lot No. 29 S. 63-27 W. 100 feet to an iron pin, joint back corner with Lots Nos. 28, 29 & 17; thence with the joint line of said Lot No. 17 N. 18-50 E. 198 feet to an iron pin, the point of beginning, and bounded by said Secondary State Highway, Lots Nos. 17, 15, 28 & 29.
This being a portion of the same property as conveyed to the Grantor by deed of record in said R. M. C. Office in Deed Book 611, Page 129, and this conveyance is made in accordance with a Trust Indenture which is of record in said Office in Deed Book 632, Page 45.
