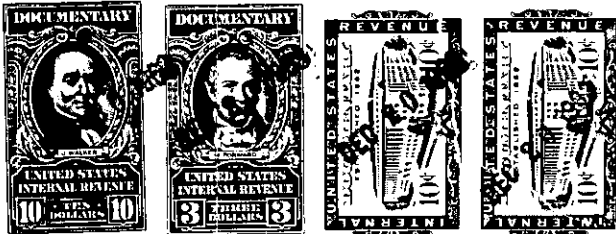
in consideration of Eleven Thousand Nine Hundred and No/100----- Dollars,

All that piece, parcel or lot of land with the improvements thereon, located in the County of Greenville, State of South Carolina on the eastern side of Pinefield Drive and being known and designated as Lot 143 according to a plat entitled South Forest Estates dated August 29, 1955 recorded in the R.M.C. office for Greenville County in Plat Book GG at page 181 and having, according to said plat, the following metes and bounds, to wit:

Beginning at an iron pin on the eastern side of Pinefield Drive, joint front corner of Lots 143 and 144 and running thence along the line of Lots 144 and 143, S. 84-40 W. 122.4 feet to a point; thence running N. 4-55 W. 84.8 feet to a point on Belvedere Road; thence running along Belvedere Road N. 75-37 E. 94 feet to a point; thence running along the curve of the intersection of Belvedere Road and Pinefield Drive (the chord of which is S. 54-48 E. 38.1 feet to a point on Pinefield Drive; thence running along Pinefield Drive S. 5-20 E. 75 feet to the point of beginning.

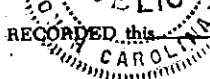
