FOR AND IN CONSIDERATION OF Ten and no/100 - - - the receipt of which is hereby acknowledged, Ella Moton Brandon, a widow hereinafter referred to as Grantors (whether one or more), do hereby grant and convey unto COLONIAL PIPELINE COMPANY, a Delaware corporation, its successors and assigns, hereinafter referred to as Grantee, an easement for a pipeline right of way with the right to construct, maintain, inspect, operate, protect, repair, replace, change the size of, and remove a pipeline for the transportation of liquids and/or gases on, over, and through the following described lands, of which Grantors warrant they are the owners in fee simple, County, State of South Carolina 12.60 acres more or less, being all of Lot #6, on Plat of division of lands of Estate of Nora Moton, dated December 14, 1936, on file in the Probate Judge's Office under Apartment 184, File 25, acquired by the Grantors herein by Will of Nora Moton, Probated November 14, 1923, Apartment 184, File 25, Probate Records of Greenville County, South Carolina. together with the right of unimpaired access to said pipeline and the right of ingress and egress on, over, and through the above-described land for any and all purposes necessary and incident to the exercise by said Grantee of the rights granted hereunder.

The said Grantors shall have the right to use and enjoy the above-described land except as the same may be necessary for the purposes herein granted to the said Grantee. Grantors agree not to build, create, or construct any obstructions, engineering works, or other structures over said pipe line nor permit the same to be done by others.

In addition to the above consideration, Grantee agrees to repair or to pay for any actual damage which may be done to growing crops, 'timber, fences, buildings, or other structures directly caused by Grantee exercising any rights herein granted.
