in consideration of the sum of \$1500.00 and assumption of mortgage. in the State aforesaid, DOLLARS,

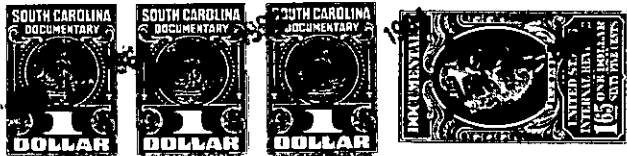
