in consideration of Three Thousand Five Hundred Sixty & 36/100 ----- Dollars,

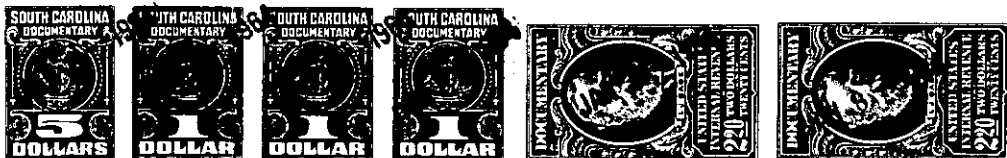
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Luther Ray Moon and Ruth B. Moon, their heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the eastern side of Piedmont Park Road (formerly Old Rutherford Road) and being known and designated as Lot No. 18 of Mountain View Circle Subdivision as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "W", at Page 181 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Piedmont Park Road at the joint front corner of Lots Nos. 18 and 19 and running thence along said Road S. 5-20 W. 100 feet to an iron pin; thence along the line of Lot No. 17 N. 81-35 W. 200 feet to an iron pin; thence N. 5-20 E. 100 feet to an iron pin; thence along the line of Lot No. 19 S. 81-35 E. 200 feet to the point of beginning.

The above is the same property conveyed to the grantor by deed recorded in Deed Book 734, Page 529.

The grantees assume the balance due on the mortgage from the grantor to First Federal Savings and Loan Association recorded in Mortgage Book 939, at Page 89, the balance now due and owing being \$5,939.64.
