KNOW ALL MEN BY THESE PRESENTS, that I, WILLIAM R. TIMMONS, JR.

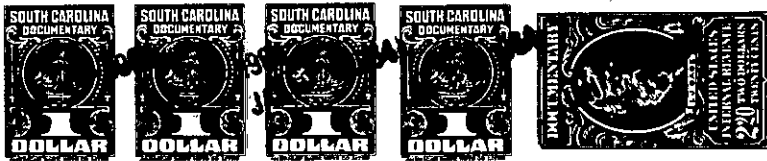
In consideration of ONE THOUSAND SIX HUNDRED AND NO/100-----(\$1,600.00)----- Dollars,

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 55 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book XX at Page 9, and having the following metes and bounds, to wit:
