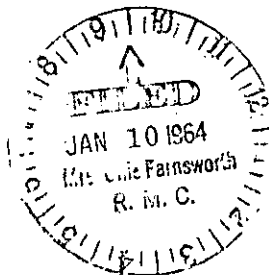

KNOW ALL MEN BY THESE PRESENTS, that I, M. W. Fore

in consideration of Seven Hundred Twenty Five & NO/100 (\$725.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Catherine L. Ashmore, her heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, being known and designated as Lot No. 6, of a subdivision known as Bel Aire Estates, as shown on a plat thereof, by Madison H. Woodward Engineers, dated May 1956 recorded in the R. M. C. Office for Greenville County in Plat Book KK, at Page 19, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Staunton Bridge Road, joint front corners of Lots 5 and 6 and running thence along the line of said lots, N. 85-30 E. 223.4 feet to iron pin rear line of Lot 57; thence running with rear lines of Lots 57 and 58, S. 4-30 E. 72.53 feet to iron pin rear corner of Lot 7; thence running with line of said lot, S. 85-30 W. 221.2 feet to iron pin on Staunton Bridge Road; thence running with Staunton Bridge Road, N. 6-10 W. 72.5 feet to iron pin point of beginning.

NO residence to cost less than \$7,500.00 shall be erected on said lots; no residence shall be erected on any lot unless said lot has 50 feet or more frontage; no residence shall be built on any lot nearer than 35 feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no business buildings shall be erected on any lot other than lots fronting on Staunton Bridge Road.

THIS conveyance is subject to all easements and rights of way of record.
