All that certain piece, parcel or lot of land, lying and being on the easterly side of Michael Drive near the City of Greenville, S. C. and being designated as Lot No. 8 on the plat entitled Michael Park, as recorded in the RMC Office for Greenville County, S. C. in Plat Book XX, page 21, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Michael Drive, joint front corner of Lots 8 and 9, and running thence along the easterly side of said Drive S 30-46 W 80 feet to an iron pin, joint front corner of Lots 7 and 8; thence along the common line of said lots S 59-20 E 158 feet to an iron pin; thence N 30-56 E 80 feet to an iron pin, joint rear corner of Lots 8 and 9; thence along the common line of said lots N 59-20 W 158.2 feet to the point of beginning.
