all that piece, parcel or lot of land in Gantt Township, Greenville

County, State of South Carolina on the old Piedmont Road, being designated as
Lots 6-7-and 8, property being more fully described as follows:
Lot number six, beginning at an iron pin corner of Lot #6 and a
proposed road and running thence along said road N 61-45 W.
approximately 412.5 feet to the right of way of the P&N R. R.; thence
in a southerly direction along the right of way of said railroad to
joint line of lots nos. 6 and 7; thence S. 61-45 E. approximately
357 feet to an iron pin joint corner of lots nos. 6 and 7; thence
N. 28-15 E 100 feet to the point of beginning.

Lot number 7 beginning at a stake on the west side of said old
Piedmont Road at the southeast corner of Lot No. 6, said stake
being 100 feet in a southerly direction from the corner of a road
running thence along line of said Lot #6 N. 61-45 W. 417 feet to a
stake at center line of P. & N. R. R.; thence along said center line
of said P. & N. R. R. in a southerly direction 115 feet to a stake
at corner of Lot No. 8; thence along line of said Lot No. 8 S. 61-
45 E. 368 feet to a stake on the west side of Old Piedmont Road;
thence along said west side of Old Piedmont Road N. 28-15 E. 100
feet to the beginning corner.

Lot number 8 beginning at an iron pin on the west side of Old Pied-
mont Road at the southeast corner of Lot no. 7 and running thence
along line of said Lot No. 7 N. 61-45 W. 307 feet more or less, to
an iron pin on right of way of P. & N. R. R.; thence along said
right-of-way of P&N. R. R. in a southerly direction 115 feet to an
iron pin at corner of Lot no. 9; thence along line of said Lot No.
9 S 61-45 E. 265 feet more or less, to an iron pin on the west side
of Old Piedmont Road; thence along said west side of Old Piedmont
Road N. 28-15 E 100 feet to the beginning corner.
