REAL PROPERTY AGREEMENT

In consideration of such loans and indebtedness as shall be made by or become due to THE CITIZENS AND SOUTHERN NATIONAL BANK OF SOUTH CAROLINA (hereinafter referred to as "Bank") to or from the undersigned, jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty-one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree

- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and
- Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property de-scribed below, or any interest therein; and
- Hereby assign, transfer and set over to Bank, its successors and assigns, all monies now due and hereafter becoming due to reigned, as rental, or otherwise. and howsoever for or on account of that certain real property situated in the County of Greenville , State of South Carolina, described as follows:

All of that certain lot of land with the buildings and improvements thereon in the City of Greenville, in Butler Township, County of Greenville, State of South Carolina, on Keith Drive and being known and designated as Lot No. 6 of the property of W. T. Patrick and Wm. R. Timmons, Jr., which plat is recorded in the R. M. C. Office for Greenville County in Plat Book "EE" at page 157, and being described as follows:

BEGINNING at a point on the Eastern side of Keith Drive at the joint front corner of Lots Nos. 5 and 6 and running thence N. 72-48 E. 175 feet to a point at the joint rear corner of Lots 5 and 6; thence S. 17-12 E. 64 feet to a point at the joint rear corner of Lots 6 and 7; S. 72-48 W. 175 feet to point on the Eastern side of Keith Drive at the joint front corner of Lots 6 and 7; thence with the eastern side of Keith Drive, N. 17-12 W. 64 feet to the point of beginning. and hereby irrevocably authorize and direct all lessees, escrow holders and others to pay to Bank, all rent and all other monies whatsoever and whensoever becoming due to the undersigned, or any of them, and howsoever for or on account of said real property, and hereby irrevocably appoint Bank, as attorney in fact, with full power and authority, in the name of the undersigned, or in its own name, to endorse and negotiate checks, drafts and other instruments received in payment of, and to receive, receipt for and to enforce payment, by suit or otherwise, of all said rents and sums; but agrees that Bank shall have no obligation so to do, or to perform or discharge any onligation, duty or liability of the undersigned in connection therewith.

- 4. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.
- 5. That Bank way and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
