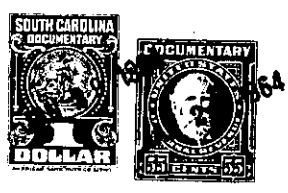

All that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 40 of Section No. 1 of Peace Haven as shown on plat thereof recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book VV, at Page 83, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the southwestern corner of the intersection of Pine Drive and Elm Street and running thence along Elm Street S. 21-24 E. 200 feet to an iron pin; thence S. 65-18 W. 100 feet to an iron pin at the joint rear corner of Lots Nos. 40 and 41; thence along the line of Lot No. 41, N. 21-24 W. 199.4 feet to an iron pin on the southern side of Pine Drive; thence along the southern side of Pine Drive N. 64-57 E. 100 feet to the beginning corner.
